### **1. Fees for Nursing Homes**

“Bed” is defined as licensed-and-not-laid away

A minimum fee\*\* of \$75.00 per month will apply for the duration of the contract

## **3. Fees for Independent Living Facilities**

Satisfaction surveys for tenants of independent living facilities will be billed at \$3.75 per survey administered. Satisfaction surveys for employees of independent living facilities will be billed at \$2.95 per survey administered.

## **4. \*\*Provision for Multiple Facilities**

If an organization operates any combination of nursing facility(ies) and housing with services establishment(s), and if the organization enrolls two or more of them at the same time, and if the total monthly fee is less than \$75.00, a minimum monthly fee of \$75.00 will apply to the organization as a whole. If such an organization elects to enroll nursing facility(ies) or housing with services establishment(s) at different times and the monthly minimum is not met, a \$75.00 minimum monthly fee will be charged for each entity.

## **5. \*\*\*Long Term Care Imperative “Data Institute” Fee**

Care Providers of Minnesota and Minnesota Health and Housing Alliance, acting as the Long Term Care Imperative, will add 15% to the My InnerView base fee to fund the development and maintenance of a joint “Data Institute” and associated activities.
